Dear Ms. Bachman,

VFS LLC is in receipt of your March 10, 2020 letter to cease fuel cell construction work at the Town of Montville WPCA. In accordance with your letter all fuel-cell related construction work at this site has ceased and erosion and sedimentation controls around the work area have been properly established.

VFS LLC states:

1. VFS provided notice to our general contractor, Sarracco Mechanical Services, directing them to cease all project construction at the site as per your instruction (please see attachment 1 to this letter)
2. All fuel-cell related construction work at the site has ceased.
3. Sarracco Mechanical immediately installed additional silt fencing and additional inlet protection to protect the site environment from erosion, as you have requested
4. Montville WPCA Site pictures showing the erosion and sedimentation controls are attached for your review (please see attachment 2 to this letter)
5. Inspection of erosion control measures will be conducted weekly and after any rain event greater than 0.2 inches and a written report will be left on site for inspection.

Today, VFS received written notification by the Connecticut Siting Council to immediately cease all fuel cell related construction on the Montville WPCA Doosan Fuel Cell Project. This letter is your notification to do the same. Please stop all construction activities at the Montville site until further notice.

Regrettably, VFS has missed a required legal step with the CT Siting Council and its fuel cell project approvals. Until the Siting Council has had the appropriate time to review the project per their requirements, all construction activities are on hold.
