RE: **PETITION NO. 1398A** - LSE Pictor, LLC petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a 1.99-megawatt AC solar photovoltaic electric generating facility on an approximately 104 acre parcel located off of Platt Hill Road, Winchester, Connecticut and associated electrical interconnection. **Reopening of this petition based on changed conditions pursuant to Connecticut General Statutes §4-181a(b).**

During a public meeting of the Connecticut Siting Council (Council) held on February 11, 2021, the Council voted to grant LSE Pictor, LLC's January 15, 2021 Motion to Reopen the Council's September 28, 2020 denial without prejudice of a declaratory ruling for the construction, maintenance and operation of a declaratory ruling for the construction, maintenance and operation of a 1.99-MW solar photovoltaic electric generating facility in Winchester based on changed conditions, pursuant to Connecticut General Statutes \$4-181a(b). Pursuant to Regulations of Connecticut State Agencies \$16-50j-40, the Connecticut Siting Council hereby solicits your written comments on the above-referenced reopened petition.
