Dear Ms. Bachman:

In its July 20, 2020 decision (the "Decision"), the Connecticut Siting Council (the "Council") approved the construction, maintenance and operation of a 12.25-megawatt AC solar photovoltaic electric generating facility (the "Facility") to be located at 424 Snake Meadow Road in Plainfield, Connecticut.

Condition No. 6 of the Decision requires that the Facility be constructed within three years from the date of the mailing of the Council's Decision. In accordance with Condition No. 7 of the Decision, Revity Energy, LLC (the "Company") hereby respectfully requests a two-year extension of time – until July 20, 2025 – to complete construction of the Facility. The Company continues to evaluate the economic viability of the project and identify ways to capitalize on the State's emergent clean energy opportunities, thereby, ensuring that the project advances the State's clean energy goals and delivers clean and affordable electricity.
