RE: **PETITION NO. 1411** – New Cingular Wireless PCS, LLC (AT&T) petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed installation of a small cell wireless telecommunications facility on the roof of an existing commercial building located at 132 Greenwood Avenue, Bethel, Connecticut.

Dear Attorney Chiocchio:

The Connecticut Siting Council (Council) received the petition for the above-referenced facility on June 9, 2020.

According to Section 16-50j-39a of the Regulations of Connecticut State Agencies, “No declaratory ruling shall be issued to any person until a complete petition containing all information deemed relevant by the Council has been filed.”

Staff has reviewed this petition for completeness and has identified the following deficiencies:

1. Notice to Carl Goding and Marlene Alvarez-Goding (Parcel\_ID: 22 30 17A), Timothy Robert and Aretta J. Gordish (Parcel\_ID: 22 30 17), and Clifford and Diana Canfield (Parcel\_ID: 22 30 18) is not evident; and
2. Provide an updated Abutters map with the above referenced property owners identified.

Pursuant to Section 16-50j-40 of the Regulations of Connecticut State Agencies, “Prior to submitting a petition for a declaratory ruling to the Council, the petitioner shall, where applicable, provide notice to each person other than the petitioner appearing as record as an owner of property which abuts the proposed primary or alternative sites of the proposed facility, each person appearing of record as an owner of the property or properties on which the primary or alternative proposed facility is to be located, and the appropriate municipal officials and government agencies. Proof of such notice shall be submitted with the petition for declaratory ruling.”

Therefore, the petition is incomplete at this time. The Council recommends that the petitioner provide proof of service of a copy of the petition for a declaratory ruling on Carl Goding and Marlene Alvarez-Goding, Timothy Robert and Aretta J. Gordish, and Clifford and Diana Canfield and an updated Abutters map with the above referenced property owners identified on or before July 16, 2020. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to July 16, 2020.
