Dear Ms. Bachman:

I am following up on your correspondence of July 29, 2020 related to this Petition and my July 22, 2020 correspondence on this matter. In your July 29, 2020 letter, you informed the project that its Petition was deemed incomplete by the Council due to the Council not receiving notice from the Department of Energy and Environmental Protection that the project will not have an adverse impact on core forest and the Department of Agriculture that the project will not have an adverse impact on prime farmland. It was Petitioner's understanding that DEEP had already submitted these materials to the Council and that the Department of Agriculture's filing would be submitted to the Council shortly. Petitioner will follow up with both of these agencies to ensure that the Council receives these materials prior to the August 28, 2020 deadline referenced in your letter.

You also indicated that the Council wished to have Petitioner provide proof to the Council that a notice of the filing of the Petition was provided to abutting property owners and the appropriate governmental officials in accordance with RCSA § 16-50j-40. This information was provided to the Council on July 22, 2020. A copy of that July 22, 2020 correspondence is included with this letter.

As I indicated in my July 22, 2020 letter, abutters were provided with two formal notices of the Petition on June 2, 2020 and June 16, 2020, in addition to the informal notices provided to the abutters as articulated in the Petition and Appendix K of the Petition. Governmental officials were notified of the Petition on June 16, 2020. A copy of these materials is once again enclosed for your review. It would be my suggestion that the contents of the July 22, 2020 letter be incorporated as an addendum to Appendix K of the Petition, but the Petitioner is happy to handle the matter in any fashion the Council so desires.


