RE: **PETITION NO. 1445** – The Connecticut Light and Power Company d/b/a Eversource Energy declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed 1588 Line Rebuild Project, consisting of the replacement and reconductoring of electric transmission line structures along approximately 2.65 miles of its existing 115-kilovolt (kV) electric transmission line within existing Eversource transmission line right-of-way (ROW) that extends from Wallingford Electric's Colony Substation, located at 15 Old Colony Road, Wallingford and Wallingford Electric's North Wallingford Substation, located at 130 Thorpe Avenue, Wallingford, Connecticut, and related electric transmission line structure improvements.

Dear Ms. Farrell:

The Connecticut Siting Council (Council) is in receipt of the email correspondence dated October 21, 2021, regarding temporary changes to work hours for the above-referenced declaratory ruling that was issued by the Council on June 18, 2021.

Pursuant to Condition No. 1 of the Council's Declaratory Ruling, your request to perform work from 7:00 am until 7:00 p.m. on Sunday, October 24, 2021; Sunday, November 7, 2021; Sunday, November 14, 2021; and Sunday, November 21, 2021; and from 7:00 a.m. until 3:00 p.m. on Sunday, October 31, 2021 (Halloween) is hereby approved.

The Sunday work hours are necessary to complete construction work to meet the scheduled inservice date of December 31, 2021 for the project.

This approval applies only to the request for changes to work hours dated October 22, 2021. Any significant changes to the project require advance Council notification and approval.
