The Connecticut Siting Council (Council) is in receipt of the email correspondence dated January 4, 2023, regarding temporary changes to work hours for the above-referenced declaratory ruling that was issued by the Council on July 30, 2021.

Pursuant to Condition Nos. 1 and 3 of the Council's Declaratory Ruling, your request to perform work from 7:00 a.m. until 7:00 p.m. on the following Sundays: January 8, January 15, January 22, and January 29, 2023 is hereby approved. The Sunday work hours are necessary to complete testing and commissioning work during a scheduled outage.

This approval applies only to the request for changes to work hours dated January 4, 2023.

Please be advised that deviations from the standards established by the Council in the Declaratory Ruling are enforceable under the provisions of Connecticut General Statutes § 16-50u.
