The Connecticut Siting Council (Council) is in receipt of the email correspondence dated February 22, 2022, regarding temporary changes to work hours for the above-referenced declaratory ruling that was issued by the Council on July 30, 2021.

Pursuant to Condition No. 1 of the Council's Declaratory Ruling, your request to perform work from 7:00 p.m. until 10:00 p.m. on Wednesday, February 23, 2022 at Mansfield Substation is hereby approved. Eversource Energy is requesting approval from Connecticut Siting Council staff for extended hours from 7 PM to 10 PM on February 23, 2022, to pour concrete for the distribution switchgear at Mansfield Substation. Due to the proximity of the concrete truck to the energized substation equipment, a slower concrete pour would be required. The project anticipates all the concrete to be poured prior to 7 PM; however, the foundation surface finishing and curing setup is anticipated to continue past this time to facilitate the smooth finish required for the switchgear building to be installed.
