The Connecticut Siting Council (Council) is in receipt of the correspondence dated November 21, 2023 regarding temporary changes to work hours for the above-referenced Declaratory Ruling that was issued by the Council on July 30, 2021.

Pursuant to Condition No. 1 of the Council's Declaratory Ruling, your request to perform work during overnight hours for one or two weeknights during the week of November 27, 2023 to perform a 24-hour monitoring cycle of oil that will be used to fill the new transformer in advance of commissioning is hereby approved.

This approval applies only to the request for temporary extended work hours dated November 21, 2023.

Please be advised that deviations from the standards established by the Council in the Declaratory Ruling are enforceable under the provisions of Connecticut General Statutes § 16-50u.

Re: Petition No. 1454 – Modifications to Mansfield Substation Request for Extended Work Hours

Dear Ms. Bachman:

Eversource Energy is requesting Siting Council staff review and approval of overnight work hours on one or two nights between Monday, November 27, 2023, and Friday, December 1, 2023. As part of the assembly and testing of the new Mansfield transformer, the project requires the ability to have two people (transformer assembly lead and an Eversource construction representative) on-site through the night during the required 24 hour monitoring cycle of the oil that will be used to fill the new transformer ahead of commissioning.

These two people will be within the construction trailer, aside from periodic walks to the oil fractioning tank in the substation yard to record readings. There will be limited physical work and vehicle use during this time, and the gates to the road will be closed and secured. There will be a generator running through the evening, as well as a vacuum pump and processing machine. Noise will be limited to these sources during this process.

We have notified the Town of Mansfield of our intention to submit this request to the Council. We will continue to work with the Town and nearby residents to apprise them of the work and to resolve any potential conflicts or concerns.
