Pursuant to Condition Nos. 1 and 3 of the Council's Declaratory Ruling, your request to perform work from 7:00 AM until 7:00 PM on the following Sundays: January 7, 14, and 21, 2024 to complete testing and commissioning of a new transformer is hereby approved.

Please be advised that deviations from the standards established by the Council in the Declaratory Ruling are enforceable under the provisions of Connecticut General Statutes § 16-50u.

Eversource Energy is requesting Siting Council staff review and approval, per Condition 1 of the July 30, 2021, ruling on Petition No. 1454, for Sunday work hours on multiple dates during January 2024, from 7:00 A.M. to 7:00 P.M. For each of the requested Sundays, Eversource is requesting authorization to continue the sequence of events for the testing and commissioning of the new 3X transformer. The work must be completed before the in-service date of January 24, 2024.

During this final phase of construction, work activities during Sunday work hours will not include large construction equipment, and will include noise limited activities, as work permits.


The specific dates subject of this Sunday hours work request are:
