On February 28, 2023, Homestead Fuel Cell 1, LLC ("HFC1" or the "Company") requested the Connecticut Siting Council ("Council") withdraw the Company's Development and Management Plan ("D&M Plan") dated July 1, 2022. The Council acknowledged the request to withdraw the plan on February 28, 2023.

The Company now wishes to inform the Council that it will not be developing the project at the 441 Homestead Avenue property. While the Company is hopeful another location in Hartford can be found for the project, the Company is no longer pursuing development opportunities at the approved location. The Company thanks the Council and its staff for their time and efforts in connection with the Petition.
