RE: **PETITION NO. 1459** - The Connecticut Light and Power Company d/b/a Eversource Energy Declaratory Ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed modifications to its existing Shunock Substation located at 25 Pendleton Hill Road, North Stonington, Connecticut and related electric transmission line structure improvements. **Request for Temporary Extended Work Hours.**

Dear Kathleen Shanley:

The Connecticut Siting Council (Council) is in receipt of the email correspondence dated October 10, 2023 regarding temporary changes to work hours for the above-referenced Declaratory Ruling that was issued by the Council on October 8, 2021.

Pursuant to Condition No. 1 of the Council's Declaratory Ruling, your request to perform work from 7:00 AM until 7:00 PM on the following Sundays – October 15, 22 and 29, 2023 - is hereby approved. The Sunday work hours are necessary to perform work within the substation during a scheduled outage and to make up for previously scheduled work that was canceled due to equipment issues.

This approval applies only to the request for changes to work hours dated October 10, 2023.

Please be advised that deviations from the standards established by the Council in the Declaratory Ruling are enforceable under the provisions of Connecticut General Statutes § 16-50u.

Dear Ms. Bachman:

Eversource Energy is requesting Siting Council staff review and approval for extended work hours of 7:00 a.m. to 7:00 p.m., on the following Sundays: 10/15/2023, 10/22/2023 and 10/29/2023 for Petition 1459 (North Stonington) at Shunock Substation. The September outages were cancelled due to an issue with the new equipment. This delayed the outage-dependent work that was scheduled for September to October. The Sunday work hours are required to complete relay testing which will enable other work needed in advance of a other outage-dependent work needed to energize the synchronous condenser and the new transformer supplying power to the synchronous condenser.

We have notified the Town of North Stonington of our intention to submit this request to the Council and the Town did not have any objections. We will continue to work with the Town, as well as nearby residents to apprise them of the work and to resolve any potential conflicts or concerns.
