PETITION NO. 1468 – The Connecticut Light and Power Company d/b/a Eversource Energy declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed Montville to Horton Cove Rebuild Project consisting of the replacement and reconductoring of electric transmission line structures along approximately 0.6 mile of its existing Nos. 100 69-kilovolt (kV) and No. 1410 115-kV electric transmission lines within existing Eversource electric transmission line right-of-way between Horton Cove and Montville Substation in Montville, Connecticut, and related electric transmission line and substation improvements.

The Connecticut Siting Council (Council) is in receipt of the email correspondence dated November 3, 2022, regarding a modification to the approved work hours request for the above-referenced declaratory ruling that was issued by the Council on January 28, 2022.
