Dear Attorney Bachman:

At the May 16th Town Council meeting, the Town Council voted to send a letter to the Siting Council stating their opposition to the proposed solar field.

The North Street Golf Range has been a recreational fixture in Enfield for over 30 years, serving thousands of people from the Greater Enfield area, as the petitions that were submitted indicate. This was never more evident than in the last 2 years during the pandemic, when people sought ways to be active outdoors.

The Town Council believes that it is in the best interest of the Town to work with Verogy to identify another site that would be appropriate, and allow the golf range to continue its lease in its current location.
