1. What is the estimated cost of the proposed project?
2. Would Dish's proposed facility have backup power? If yes, provide detail, backup power source and anticipated run time.
3. Referencing pages 3-4 of petition Attachment 4 – Structural Analysis Report, what carriers are located on the existing facility at what height?
4. Would the proposed installation support 5G services? If yes, in what frequency range?
5. Page 2 of the petition states that “no native trees will need to be removed...” Would any vegetation need to be removed, such as landscaping? If yes, would landscaping be replanted in areas where it is removed?
6. Would grading be necessary?
7. Page 3 of the petition states that “the installation of a **temporary** tower at the property will not have a substantial adverse environmental effect...” (Emphasis added). Explain.
8. Provide the proposed construction hours, days of the week and the duration of construction.
9. Would the proposed fence match the existing compound fence?
