RE: **PETITION NO. 1531** – The Connecticut Light and Power Company d/b/a Eversource Energy declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed 1200/1300 Line Structure Replacement Project consisting of the replacement and reconductoring of approximately 0.39 mile of its existing No. 1200 and No. 1300 115-kilovolt electric transmission lines within existing Eversource electric transmission line right-of-way between Eversource's Windsor Locks Substation in Windsor Locks and Warehouse Point Junction in East Windsor, Connecticut and related transmission line and substation improvements.

The Connecticut Siting Council (Council) is in receipt of the email correspondence dated March 30, 2023, regarding a temporary change to work hours for the above-referenced Declaratory Ruling that was issued by the Council on September 30, 2022.

Eversource is requesting these additional work hours in order to complete the clipping and preparing for the next conductor pull so that all work can be completed within the current outage. This work has been delayed due to the high winds today and forecasted weather for Saturday that prevented the work from being today and will prevent it on Saturday.

The work during the extended hours will require bucket trucks to be located on the ground at work pad located at Structures 6207 and 6208 and inside the Windsor Locks Substation.

We were unable to notify the Towns of Windsor Lock and East Windsor today as their offices were closed, but will be notifying them first thing tomorrow morning.
