RE: **PETITION NO. 1549** – The Connecticut Light and Power Company d/b/a Eversource Energy Declaratory Ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed 1714 Line Rebuild Project consisting of the replacement and reconductoring of approximately 9.4 miles of its existing Nos. 1714, 1720, and 1222 115-kilovolt (kV) electric transmission lines and one structure along its 1637 line within existing Eversource electric transmission right-of-way between Eversource's Weston Substation, 85 Weston Street in Weston and the United Illuminating Company's Old Town Substation, 122 Kaechele Place in Bridgeport, Connecticut traversing Weston, Fairfield, Easton and Bridgeport and related electric transmission line and substation improvements. **Request for Project Change.** 

Dear Kathleen Shanley:

The Connecticut Siting Council (Council) is in receipt of your correspondence dated November 17, 2023 regarding a project change for the above-referenced Declaratory Ruling issued by the Council on February 16, 2023.

Pursuant to Condition No. 1 of the Council's February 16, 2023 Declaratory Ruling, the request for a new offright-of-way (ROW) access road extending from Morehouse Drive in Fairfield, traversing Town of Fairfield property, and ending at the Eversource ROW at Structure 19724 is hereby approved.

This approval applies only to the project change in the correspondence dated November 17, 2023.

Please be advised that deviations from the standards established by the Council in the Declaratory Ruling are enforceable under the provisions of Connecticut General Statutes §16-50u.

**Proposed Project Modification** 

Dear Attorney Bachman:

On February 16, 2023, the Connecticut Siting Council ("Council") approved Petition 1549 referenced above. Eversource is seeking Council staff approval for the following change:

Add an off-ROW access road starting at Morehouse Drive in Fairfield and ending at the Eversource ROW at proposed Structure 19724, providing access to this structure as well as Structure 19723. (See Attachment A – Map sheet 13) The beginning portion of the proposed off-ROW access road is an existing paved service road and then continues on to an existing walking trail that will be matted. This proposed off-ROW access road will eliminate the need for constructing an in-ROW gravel access road between Structures 19724 and 19725.

This new off-ROW access road is on Town of Fairfield property, and they have agreed to allow Eversource to use it as proposed.

Eversource requests approval for the requested modification. An original and two copies of this request will be hand delivered to your office this afternoon.
