9/28/22- APT sent a follow up email on the previous discussion as well as send over a draft civil plan of the project for discussion purposes.

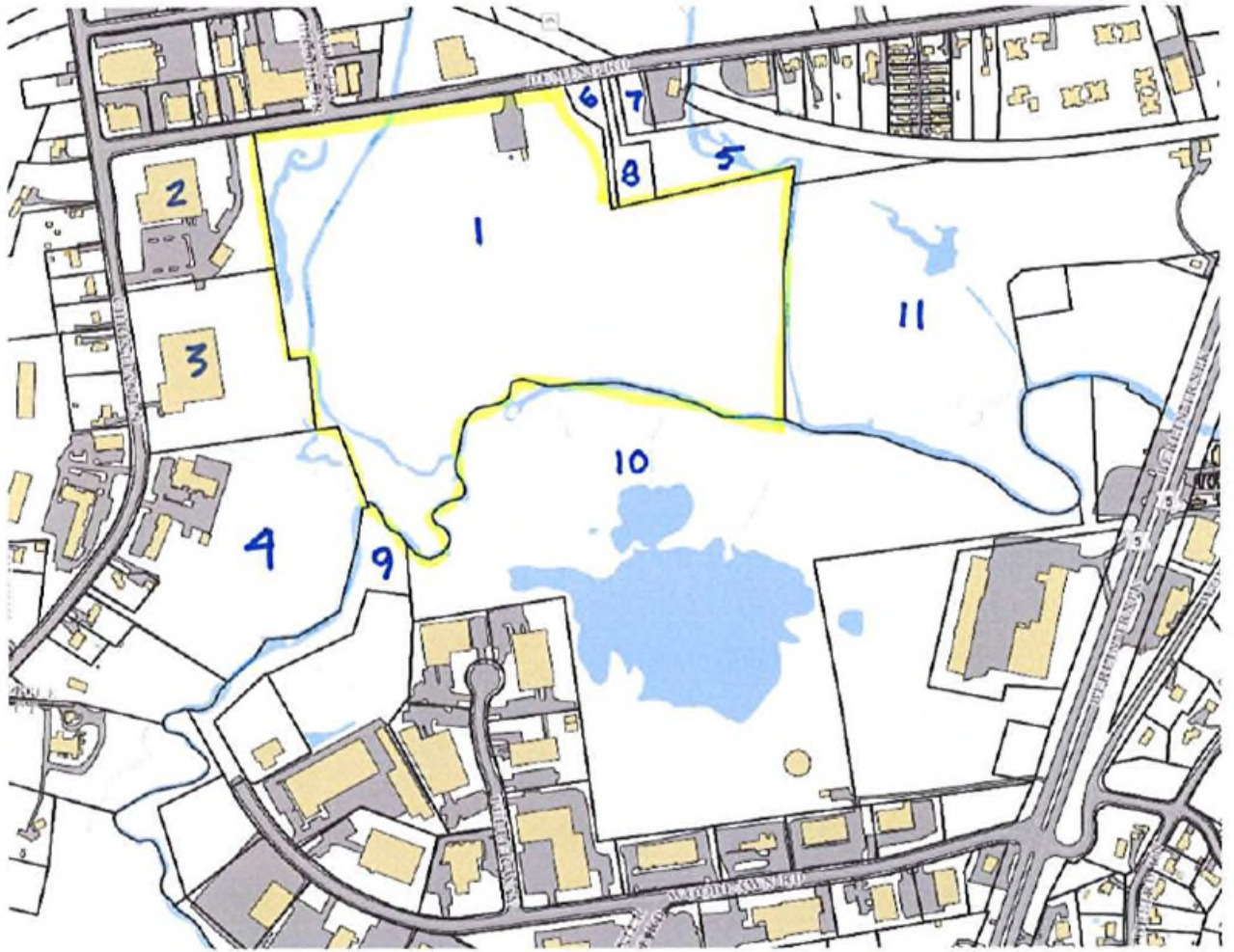
