


As the Representative for the 57th House District which includes Ellington and East Windsor, I would like to thank the CT Siting Council for the opportunity to provide public comment on Petition 1558 regarding the proposed solar construction in Ellington at 24 Middle Road. This site is the most recent in a trend of solar construction throughout my district on land previously designated for agricultural purposes. The completion of this site would bring the total amount of power generated across the district to over 150 MW with many projects in the pipeline. The 57th house district hosts a grossly disproportionate burden of the state's green energy goals and this has come at a large cost to prime and important farmland and abounded neighborhood nuisances.

In the past few months my inbox has been full of residents who have concerns about solar construction, the lion's share, neighbors to a nuisance project on the same road. Their issues are less with the transition to greener energy but with this process which discounts their input. These are friendly neighbors; some with significant, lasting noise complaints, long standing dead tree boundaries that they view as blight. Importantly, our community is forced to shoulder an excessive amount of solar in service of the state's green energy goals, creating a likely irreversible switch of prime and important farmland to energy generation or commercial purposes.

It would be irresponsible of the CT Siting Council to continue to site solar arrays in the 57th house district, particularly on the same road with active complaints on another solar array that has yet to find resolution.

The community has delivered resounding concerns and complaints, it's the responsibility of the CT Siting council to consider these complaints and reject this and any future solar projects in this community without its consent.
