CELLCO PARTNERSHIP D/B/A VERIZON WIRELESS PETITION TO INTERVENE

Pursuant to Connecticut General Statutes (“C.G.S.”) Section 16-50n and Regulations of Connecticut State Agencies (“R.C.S.A.”) Section 16-50j-15, Cellco Partnership d/b/a Verizon Wireless (“Cellco”) hereby requests permission of the Siting Council (“Council”) to participate, as an intervenor, in the Petition No. 1559 proceeding.

Cellco is a wireless service provider, licensed to do business throughout the State of Connecticut. As described in Petition No. 1559, the proposed Crown Castle (“Crown”) telecommunications facility at 41 Padanaram Road in Danbury would fit neatly into Cellco’s network design and provide much needed service in northern portions of the City of Danbury.

Cellco’s involvement in the Petition No. 1559 proceeding would aid the Council in evaluating additional need considerations as set forth in C.G.S. § 16-50g. Cellco’s expertise and experience in designing, constructing, operating and maintaining a wireless telecommunications system in the State of Connecticut in accordance with the rules and regulations of the Council and the Federal Communications Commission, may be of benefit to the Council in resolving

issues presented in Petition No. 1559. Cellco has been admitted as an intervenor in prior Siting Council proceedings and expects to actively participate in Petition No. 1559.

For the above-stated reasons, Cellco seeks permission to participate in this docket as an intervenor.
