Notice Pursuant to Condition No. 2

Dear Attorney Bachman:

In accordance with Condition No. 2 of the Connecticut Siting Council's ("Council's") approval of the above-referenced Petition, dated July 20, 2023, notice is provided to the Council that the Project construction contractor will stage work activities from the contractor's existing primary construction yard property located at 418 John Fitch Boulevard in South Windsor, Connecticut, (Refer to the attached Figure).

In addition, along the Project right-of-way, the contractor proposes to temporarily store equipment on existing gravel pads at 1772 Line Structures 15160, 15161, and 15162 on Eversource owned property. These gravel pads are located directly north of Haddam Neck Switching Station and are easily accessible via Cove Road (refer to Petition No. 1565 - Attachment A, Map Sheet 5).

No sediment or erosion controls are needed in conjunction with the use of the contractor's existing yard or the three gravel pads on Eversource property because no water or other sensitive resources are located nearby and there are no plans for soil disturbance.

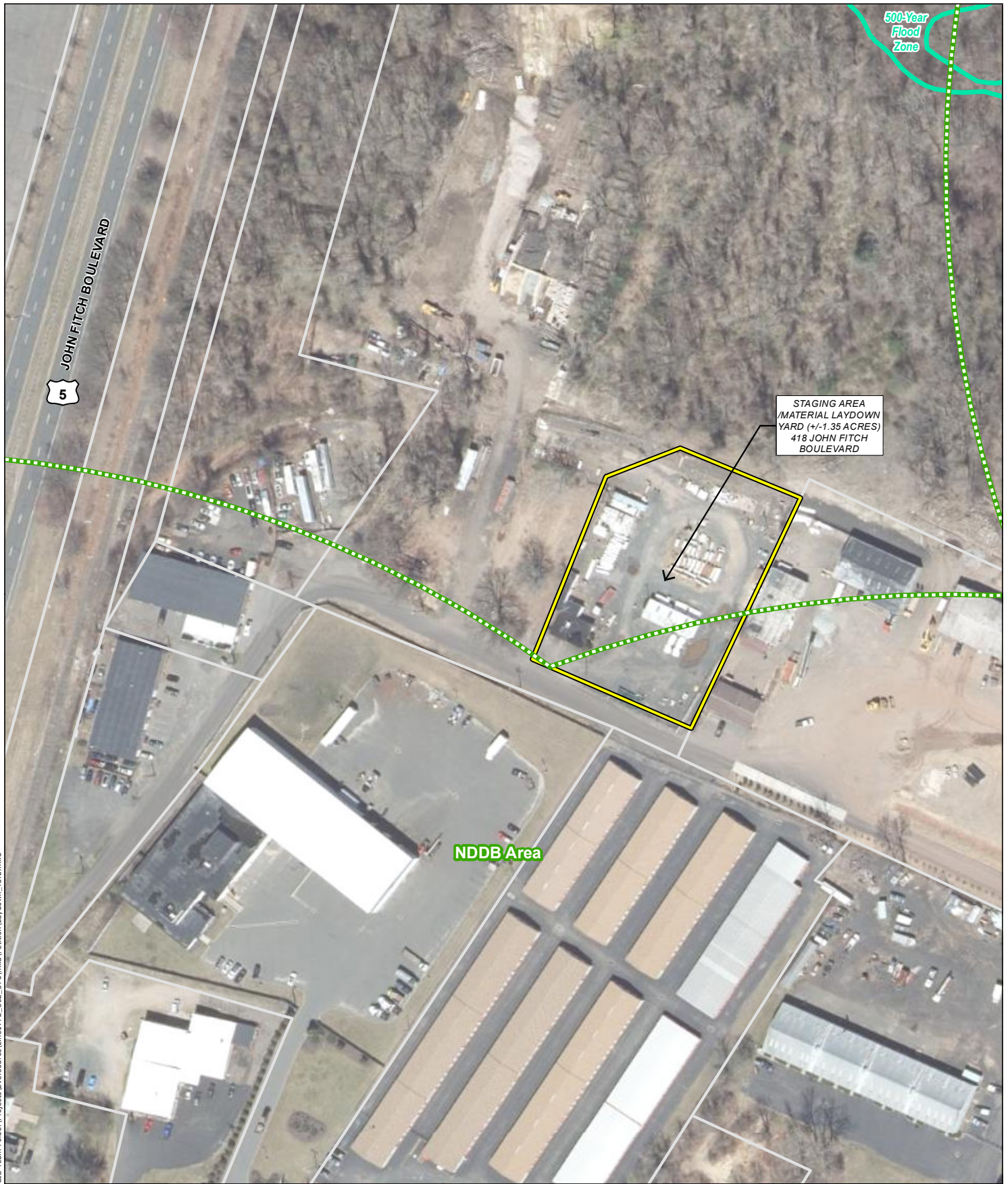

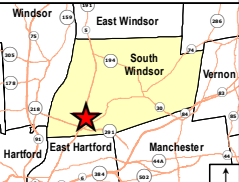
