Objection

On August 22, 2023 parties to petition 1566 Cory Spaulding and Leslie Yeisley requested access to the draft staff report for the 8/31/23 Council meeting. As parties to this petition, we object to the denial of access to pertinent records as being prejudicial and feel that our ability to participate as a party to the petition has been compromised.
