RE: **PETITION NO. 1573** - The Connecticut Light and Power Company d/b/a Eversource Energy Declaratory Ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the Brookfield Junction to Bates Rock Substation Upgrade Project consisting of the replacement and reconductoring of electric transmission line structures along approximately 6.7 miles of its existing electric transmission line right-of-way shared by its existing 115-kilovolt (kV) Nos. 1887, 1268, and 1485 Lines between Brookfield Junction in Brookfield and Shepaug Substation in Newtown, and along approximately 0.5 mile of its existing electric transmission line right-of-way shared by its existing 115-kV Nos. 1622 and 1485 Lines between Shepaug Substation and Bates Rock Substation in Southbury, Connecticut traversing the municipalities of Brookfield, Newtown and Southbury, and related electric transmission line and substation improvements. **Compliance with Condition No. 2.**

Dear Deborah Denfeld:

The Connecticut Siting Council (Council) is in receipt of correspondence dated February 28, 2024 identifying two additional Project construction staging areas at 51 Purchase Brook Road, Southbury, and provisions for erosion and sedimentation controls in compliance with Condition No. 2 of the Council's Declaratory Ruling of August 4, 2023 for the above-referenced project.

The Council acknowledges that Condition No. 2 has been satisfied. This acknowledgment applies only to the condition satisfied by the February 28, 2024 correspondence.

Please be advised that deviations from the standards established by the Council in the Declaratory Ruling are enforceable under the provisions of Connecticut General Statutes §16-50u.
