RE: **PETITION NO. 1573** - The Connecticut Light and Power Company d/b/a Eversource Energy Declaratory Ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the Brookfield Junction to Bates Rock Substation Upgrade Project consisting of the replacement and reconductoring of electric transmission line structures along approximately 6.7 miles of its existing electric transmission line right-of-way shared by its existing 115-kilovolt (kV) Nos. 1887, 1268, and 1485 Lines between Brookfield Junction in Brookfield and Shepaug Substation in Newtown, and along approximately 0.5 mile of its existing electric transmission line right-of-way shared by its existing 115-kV Nos. 1622 and 1485 Lines between Shepaug Substation and Bates Rock Substation in Southbury, Connecticut traversing the municipalities of Brookfield, Newtown and Southbury, and related electric transmission line and substation improvements. **Request for Temporary Extended Work Hours.**

The Connecticut Siting Council (Council) is in receipt of the email correspondence dated June 5, 2024 regarding temporary changes to work hours for the above-referenced Declaratory Ruling that was issued by the Council on August 4, 2023.

Pursuant to Condition No. 1 of the Council's Declaratory Ruling, your request to perform work from 9:00 AM until 7:00 PM on Sunday, June 9, 2024 between Structures 4654A and 4648A in Brookfield within a scheduled outage, is hereby approved.

Eversource Energy is requesting Siting Council staff review and approval of Sunday work hours on June 9, 2024, from 9AM to 7PM to install new structures, conductor and OPGW, between Brookfield Junction and Stony Hill Substation (Structures 4654A to 4648A) in Brookfield. The project has been delayed due to crew reassignments during recent storms in April, and recent unanticipated equipment repairs. These Sunday work hours are necessary to allow the Project to recoup time lost to complete this work within the scheduled outage window on the 1268 Line.

We have notified the Town of Brookfield of our intention to submit this request to the Council. We will continue to work with the Town of Brookfield and nearby abutters to apprise them of the work and to resolve any potential conflicts or concerns.
