The Connecticut Siting Council (Council) is in receipt of your correspondence dated May 16, 2024 regarding a project change for the above-referenced Declaratory Ruling issued by the Council on August 18, 2023.

Pursuant to Condition No. 1 of the Council's August 18, 2023 Declaratory Ruling, the request to install gravel in lieu of timber matting for the northern portion of access within the right-of-way from Structure 4066 to Structure 4066-1 is hereby approved.

This approval applies only to the project change in the correspondence dated May 16, 2024.

Please be advised that deviations from the standards established by the Council in the Declaratory Ruling are enforceable under the provisions of Connecticut General Statutes §16-50u.

Dear Attorney Bachman:

In accordance with Condition No. 1 of the Connecticut Siting Council's ruling on the above referenced Petition, dated August 18, 2023, Eversource is requesting staff approval for proposed project changes necessary to construct the Project.

Eversource initially proposed to install timber matting from Structure 4066 to 4066-1 as shown on Map Sheet 14. The landowner has been placing wood chips in the right of way and the wood chips have made the ground surface unstable. Due to safety concerns, Eversource is requesting to install a gravel access on the northerly section of the access from Structure 4066 to Structure 4066-1 in order to maintain a safe work environment. See Attachment A – Map-Sheet 14.

The landowner is aware of the modification and has agreed to the change.

The Town of Wallingford and the abutters have been notified and have no concerns.


