RE: **PETITION NO. 1577** - The Connecticut Light and Power Company d/b/a Eversource Energy Declaratory Ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the Frost Bridge to Noera Rebuild Project consisting of the replacement and reconductoring of electric transmission line structures along approximately 5 miles of its existing electric transmission line right-of-way shared by its existing 115-kilovolt (kV) 1163 and 1550 Lines between Frost Bridge Substation in Watertown to Noera Substation in Waterbury, traversing the municipalities of Watertown, Thomaston, Plymouth and Waterbury, Connecticut, and related electric transmission line and substation improvements. **Request for Temporary Extended Work Hours.**

The Connecticut Siting Council (Council) is in receipt of the email correspondence dated February 14, 2024 regarding temporary changes to work hours for the above-referenced Declaratory Ruling that was issued by the Council on September 1, 2023.

Pursuant to Condition No. 1 of the Council's Declaratory Ruling, your request to perform work from 7:00 AM until 5:00 PM on the following Sundays: February 18, February 25, March 3, and March 10, 2024 to complete work during a scheduled outage is hereby approved.

This approval applies only to the request for changes to work hours dated February 14, 2024.

Eversource Energy is requesting Siting Council staff review and approval of Sunday work hours on multiple dates from February through March from 7:00 a.m. to 5:00 p.m. For each of the requested Sundays, Eversource is requesting authorization to conduct civil, drilling, wire pulling, and structure replacement activities. The project has been delayed due to a number of factors and the request for multiple extended workdays is necessary to allow the project to be completed within the scheduled outage window on the 1550/1163 Lines.
