To Whom It May Concern:

LSE Horologium LLC (“Lodestar Energy”) intends to file a Petition for Declaratory Ruling (“Petition”) with the Connecticut Siting Council (“Council”) in June 2023. The Petition will seek approval of the location, construction, operation and maintenance of an approximately 1.99-megawatt solar photovoltaic (“PV”) project, including all associated equipment and related site improvements (the “Project”), to be located at 163 N Windham Rd in Windham, Connecticut.

The proposed Project will consist of ground-mounted solar PV panels, centralized inverters and transformers, electrical lines, a step-up transformer and fence, a station controller, a perimeter fence and an access road and substation.

Pursuant to Connecticut General Statutes § 16-50g *et seq.*, the location and/or certain features of the Project may change through the Council’s regulatory approval process. Electricity generated by the Project will be supplied to the electric grid and will supply 100% renewable energy in furtherance of Connecticut’s renewable energy goals.
