RE: **PETITION NO. 1582** - The Connecticut Light and Power Company d/b/a Eversource Energy Declaratory Ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the Pootatuck to West Devon Rebuild Project consisting of the replacement and reconductoring of electric transmission line structures along approximately 3.3 miles of its existing electric transmission line right-of-way shared by its existing 115-kilovolt (kV) 1580, 1241, 1483 and 1545 Lines between The United Illuminating Company's (UI) Pootatuck Substation in Shelton, UI's Trap Falls Substation in Shelton and Eversource's West Devon Junction in Stratford, traversing the municipalities of Shelton and Stratford, Connecticut, and related electric transmission lines and substation improvements. **Request for Temporary Extended Work Hours.**

The Connecticut Siting Council (Council) is in receipt of the email correspondence dated April 3, 2024 regarding temporary changes to work hours for the above-referenced Declaratory Ruling that was issued by the Council on October 13, 2023.

Pursuant to Condition No. 1 of the Council's Declaratory Ruling, your request to perform work from 7:00 AM until 4:00 PM on Sunday, April 7, 2024 near Structure 19520 in Stratford to prepare cellular facilities at the existing equipment shelter within a scheduled outage is hereby approved.

Eversource Energy is requesting Connecticut Siting Council staff review and approval of Sunday work hours on April 7, 2024 from 7AM-4PM to support a ground crew that is prepping cellular facilities at the existing cellular shelter at Structure 19520 off of Chapel Street in Stratford on Eversource property. No noise impacts are anticipated. This request is required due to loss of production this week for planned work with weather delays and storm response needs. This work has a short window of completion in between the transmission line major construction in order to support the overall project and outage schedule.
