PARTIES JOINT WRITTEN CONSENT TO EXTEND DEADLINE

The parties, TRITEC Americas, LLC (“TRITEC”), the Town of Bethany (the “Town”) and the Rural Bethany Association (“RBA”) submit this joint written consent to extend the statutory deadlines of the Connecticut Siting Council (“CSC”).

1. On July 11, 2023, TRITEC filed a petition with the Connecticut Siting Council (“CSC”) seeking declaratory relief to locate, construct, operate, maintain, and decommission a solar photovoltaic facility with a capacity of 0.999 MW AC and associated equipment inclusive of all solar panels, transformers, electrical switchgear, monitoring equipment, and access roadways on approximately 6.59 acres of land located at 0 & 428 Bethmour Road in Bethany, Connecticut (“Petition”).
2. On September 25, 2023, TRITEC, the Town and RBA jointly requested that the CSC stay this proceeding.

3. Unless the parties all submit a written agreement to extend the CSC's deadline, under the Connecticut General Statutes the CSC must render a decision on TRITEC's petition by January 7, 2024.

WHEREFORE, the parties hereby jointly submit their written consent to extend the CSC's statutory deadline to render a decision on the Petition to a date that follows the parties' subsequent submission of a joint request to resume these proceedings and based on a schedule to be determined at that time.
