## Petition No. 1583 TRITEC Americas, LLC Parcel Nos. 113-1 and 113-1-A 428 Bethmour Road, Bethany, Connecticut

## Pre-Hearing Interrogatories to Town of Bethany September 5, 2023

- 1. On Petition p. 4, TRITEC states it developed an "alternative project site plan" for a 11.45 MW AC solar facility on Town of Bethany (Town)-owned property at 755 Amity Road and delivered the plan to the First Selectman. Did the First Selectman receive the plan? If yes, on what date? Did the First Selectman provide comment to TRITEC regarding the "alternative project site plan"? If yes, on what date?
- 2. The TRITEC "alternative project site plan" on the Town's 755 Amity Road property is for a 11.45 MW AC solar facility. Would the Town be willing to lease the 755 Amity Road parcel for development of a solar facility? If yes, is the Town receptive to the "alternative project site plan" or any specific portions of the "alternative project site plan" as shown in Exhibit C to the Petition that could be developed for a solar facility?
- 3. Did the Town refer TRITEC to other Town-owned properties that may be available to host a solar facility? If yes, what were the locations?
- 4. Did the Town directly refer TRITEC to the Uniroyal property at 74 Amity Road? If yes, on what date?
- 5. Did the Town contact the owner of the Uniroyal property to determine if it was receptive to hosting a solar facility? If yes, on what date and who was contacted?
- 6. Do the Town's zoning regulations allow for agricultural use on the 0 and 428 Bethmour Road parcels? If yes, what uses are allowed?
- 7. Are there any Town-designated scenic roads near the proposed site? If yes, list the roads. When was the scenic designation made for each road?
- 8. The Town's request for party and CEPA intervenor status, dated August 1, 2023, refers to a DEEP Natural Diversity Database Determination letter dated November 17, 2020. What property does the letter refer to? Provide a copy of the letter.
- 9. Referring to page 3 of the Town's request for party and CEPA intervenor status, how would water quality be impacted by the proposed facility?
- 10. Referring to the Bethany Conservation Commission's Letter dated August 9, 2023, submit a bulk copy of and/or a weblink for the referenced Plan of Conservation and Development and Open Space Plan.
- 11. Referring to the Bethany Conservation Commission's Letter dated August 9, 2023, does the Plan of Conservation and Development and Open Space Plan designate the 0 and 428 Bethmour Road parcels (#113-1 and 113-1-A) for intensive use? If yes, would such a designation be contrary to providing open space and animal habitat as stated in the letter? Explain.
