Dear Member of the Connecticut Siting Council,

I am writing to formally request a hearing regarding Petition No. 1583, which pertains to the establishment of a 0.999-megawatt AC solar photovoltaic electric generating facility at 428 Bethmour Road, Bethany, CT. I would like to present the following reasons for my request:

## 1. Incompatible Land Use:

This will allow the community to present their perspectives and ensure that the decision-making process takes into account the well-being and interests of the residents of Bethany.
