Dear Ms. Bachman-

I OPPOSE this project. I am REQUESTING A HEARING on PETITION NO. 1583 for a 0.999-megawatt AC solar photovoltaic electric generating facility at 428 Bethmour Road, Bethany, CT for the following reasons:

- This is a residentially zoned area and the proposal is for a commercial facility. I didn't buy my
 house in residential, suburban Bethany to have the State of Connecticut come in and make a
 small parcel of mostly wetlands into a COMMERCIAL SOLAR FARM. I am a taxpayer and I have
 rights!
- All residents of Bethany have well water. We must protect the water supply and aquifers. I do not
 want my well contaminated by chemicals and pesticides that can lead to cancer and childhood
 leukemia.
- I have invested a great deal of money into my home and property and do not want the value to decline. I have been told by an attorney that this Solar Farm will reduce the value of my home anywhere from 20-40%. I cannot afford to lose that amount of money on the sale of my home especially when my retirement is around the corner.
- This project is being dumped in the most populated area of Bethany consisting of approximate 16 homes/families built close together on 1 -1.5 acre lots. There are other open spaces in the Town of Bethany that are less populated that this project can be moved to.
- My neighbors and I have collected more than 800 signatures in an online petition from community members who also oppose this project. Our voices need to be heard!

We are **NOT OPPOSED** to Solar, Solar Farms, or any other green energy but we are **OPPOSED** of this being in a **RESIDENTIAL AREA** of Town.

Please grant us a hearing to express these concerns.
