RE: PETITION NO. 1586 - Dominion Energy Nuclear Connecticut, Inc. petition for a

declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, that neither a new Certificate of Environmental Compatibility and Public Need (Certificate) nor a modification to its existing Certificate is required to revise the boundaries of the Millstone Power Station electric generating facility site located off Rope Ferry Road, Waterford,

Connecticut.

During a public meeting of the Connecticut Siting Council (Council) held on September 14, 2023, the Council denied the Requests for a Public Hearing received from the above-referenced persons, dated between September 1, 2023 and September 7, 2023, for the above-referenced petition for a declaratory ruling.

Pursuant to Connecticut General Statutes (CGS) §4-176(e), within 60 days after receipt of a petition for a declaratory ruling, an administrative agency in writing shall: 1) issue a declaratory ruling; 2) order the matter for specified proceedings; 3) agree to issue a declaratory ruling by a specified date; 4) decide not to issue a declaratory ruling and initiate regulation-making proceedings on the subject; or 5) decide not to issue a declaratory ruling stating the reasons for the action.

In accordance with CGS §4-176(e), during the September 14, 2023 public meeting, the Council voted to set the date by which to render a decision on this petition as no later than January 24, 2024. This date is the statutorily-mandated 180-day decision deadline for this petition under CGS §4-176(i).
