**Subject:** Request to Deny Petition 1586

To Siting Council:

I request that petition 1586 from Dominion Energy by denied for 7 reasons:

- 1. Lack of Transparency. Both Dominion Energy and the Data Company, NE Edge, have failed to clearly communicate to the public about the proposed project. In Dominion's reply to Siting Council questions, about the proposed data center, they state "...We are not aware of any concerns expressed by the Town." This is simply wrong. There are many concerns, but Dominion and NE Edge have not been forthcoming in providing project information to the public, or in responding to concerns.
- 2. **No Selection Process.** NE Edge has presented to Waterford an unsolicited proposal for a large Data Center. No other company has been considered by the Town. Waterford has not initiated a proactive selection process to solicit proposals from qualified companies. Waterford should be in the driver's seat, setting the agenda for both the <u>qualifications of the company</u> and the <u>project requirements</u>.
- 3. Lack of Experience. NE Edge has never completed a successful data center project.
- 4. **Questionable Credentials**. The current CEO of NE Edge, Thomas Quinn, was the former CEO of Verde. And Verde was sued by Montville, CT for failure to perform as promised. Montville was awarded \$33.8 M. Other suits are pending.
- 5. **Lack of Communication**. The Representative Town Members (RTM) and the First Selectman's office (Robert Brule) have not responded in a timely manner to the concerns of it's citizens, either by email, returning phone calls, or in any other way acknowledging their constituent's concerns.

- 6. Lack of Guidelines and Oversight. The State's new Tax Incentive program to attract hyper Data Centers is uncharted waters for smaller municipalities. There are insufficient project guidelines and oversight. All three (3) entities in this project (NE Edge, Dominion Energy, and Waterford) stand to profit. Waterford alone is projected to receive from NE Edge approximately \$230 M over 30 years. This would explain why Waterford is resistant to give a platform to citizens who oppose this project. The State incentivized hyper data center program has created strange bedfellows, all with profit motive, and a significant lack of guidelines and oversight.
- 7. **Need for a Public Hearing**. The citizens of Waterford are asking for a Public Hearing to address concerns about the proposed 1.5 million square foot data center near a nuclear power plant. Those concerns include noise (question 18), energy consumption (question 14), environmental impact (question 23) visual character (question 26), security, fire protection, etc. In the absence of a Public Hearing, the Town government has effectively silenced the opposition.
