RE: RE: PETITION NO. 1586 – Dominion Energy Nuclear Connecticut, Inc. petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, that neither a new Certificate of Environmental Compatibility and Public Need (Certificate) nor a modification to its existing Certificate is required to revise the boundaries of the Millstone Power Station (MPS) electric generating facility site located off Rope Ferry Road, Waterford, Connecticut.

Recently I've learned that Dominion is seeking to change the boundaries of the MPS site as a result of the town of Waterford's approval of the host Municipality Fee Agreement with NE Edge, LLC., This letter is to request that the Siting Council DENY this request.

I am an abutter to the Dominion property and ½ mile or less from the proposed data center site at 2 Gun Shot Road. After reading the Interrogatories dated August 9, 2023 and the responses of Dominion to the Siting Council I have great concern that the community, and surrounding communities have not been presented with clear information regarding the impacts of the revised boundary changes.

Many of Dominion's responses state that details of the proposal are not yet final which raises question as to why the Siting Council would move forward without further detail. In addition to DENIAL of this petition I would also like to request that the Siting Council hold a public hearing to learn about the growing list of concerns from community members regarding the boundary changes.

Please consider that many people in the Town of Waterford and surrounding communities will be affected by your decision. I have personal concern as to the effect the proposed data center will have on our immediate environment and the safety of the greater community. Many neighbors are just hearing about this proposal as there has been little public discussion to date, and as an abutter I was not informed of the proposal by Dominion, NE Edge, LLC, or the Town of Waterford. Please call for a public hearing on this matter.
