Connecticut Siting Council,

On behalf of United States Parachute Association (USPA), the national membership organization representing over 42,000 skydivers and more than 230 USPA-affiliated skydiving centers across the country, and Connecticut Parachutists Inc. (CPI), one of the oldest and most popular skydiving centers in the northeast, we are deeply concerned about the proposed solar array that is planned to be constructed at Ellington Airport.

It is insufficient that USS Somers Solar LLC has not performed a study to consider the potential impacts of the solar array on the reduction of available safe parachute landing area, visual effects, and impact of turbulence on parachutes and pilots landing at the airport. Our organization cautiously urges the Siting Council to reject, or at least delay, the approval of this project until thorough and independent safety analysis is conducted. USPA trusts independent studies will accurately assess the risks and impacts of the proposed solar array on parachute operations at Ellington Airport.

The proposal to locate the solar array in the "north field" adjacent to the parachute landing area and airport runway reduces the available safe options creating serious hazards to powered flight and skydiving operations. Currently skydivers are trained to use this field as a safety measure and over the years countless skydivers have performed safe emergency landings there. Moreover, it also encloses the flight path of the aircraft that carry skydivers to their jump altitude. This project poses a serious hazard to both skydivers and pilots, as it creates a large obstacle that will interfere with their landing approach and emergency procedures. The safety of skydivers, pilots, and the public should be our top priority. We believe that this project could jeopardize safety.

CPI employs dozens of people and attracts thousands of visitors to the area each year. The proposed solar array would jeopardize their ability to operate safely and could have a devastating impact on their business.

USPA urges the council to consider the safety and economic concerns raised by USPA, CPI, and other opponents of the proposed solar array. We look forward to being a collaborative partner with the council and appreciate your consideration of this matter.
