MEMORANDUM

I have reviewed the submitted information. The following comments are offered for your consideration.

- 1. The proposed installation will not have any physical impact on the immediate area. The housing for the system will be enclosed into two chimney-like structures located on the roof and the only additional ground cover will be created by the over-ground equipment. The increase of the storm water runoff will be negligible.
- 2. The applicant requests an installation of a new telecommunication facility. The most recent cell coverage mapping was done in 2014 and since then the map has not been updated. Cell phone connections appears to be adequate at the grounds of local schools located at the vicinity of the site (Central Middle School, North Street School, Greenwich High Schools and Greenwich Country Day School). The applicant should demonstrate the need and prove the strength of the proposed system is not excessive for the area's needs. A map locating all the local antennas and their radius of coverage should be provided. The applicant should demonstrate there are no overlaps which may unnecessarily amplify the strength of emitted signal.
- 3. The Connecticut Department of Public Health states "the safe distance to keep away from an antenna depends on many factors including the antenna type, the operating power of the antenna, the direction of the transmitted beam, and the presence of shielding materials such as buildings." Students and teachers attending the four of the above-mentioned schools will be given no choice but stay under the RF influence for several hours a day, every day except for weekends. This accumulative effect may create a chronic condition they are not able to avoid. The applicant stated, the new facility will be capable to provide 5G wireless service in the future. There are many studies done showing the harmful health effects on humans, especially developing brains of children. The scientists are divided on how much is too much, but none of them denies the harmful effect of RF radiation. 4. Recent studies demonstrate FR emitted even at a low-level causes harm in every animal model studied, especially bees and birds. They depend on the earth's natural magnetic fields for orientation, migration, food-finding abilities, mating, nest and den building, territorial maintenance, and defense. RF radiation interferes with the earth's natural magnetic field. In the light of changing climate and steep decline of wildlife population special attention should be provided to the areas such golf courses which are not densely developed and provide habitat or migratory ways to wildlife.

At a public meeting held on November 2, 2023, the Planning and Zoning Commission considered the above-referenced petition and has the following comments:

The Planning and Zoning Commission notes the the proposal for the installation to be concealed within the structure of a new faux chimney appears attractive and consistent with the architecture of the building to which it will be attached and appears to meet the Town of Greenwich Building Zone Regulations for rooftop structures. The proposed location is within a mile of several public and private schools. The Commission notes the concerns from the town's environmental affairs department and requests a response be provided to ensure the operating specifications for this facility are being checked and meet the acceptable levels as permitted by the FCC and state laws.
