RE: **PETITION NO. 1598** – Windsor Solar One, LLC petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a 3.0-megawatt AC solar photovoltaic electric generating facility located at 445 River Street, Windsor, Connecticut, and associated electrical interconnection.

Continuation of Evidentiary Hearing

The Connecticut Siting Council (Council) shall continue the evidentiary hearing for the above-referenced proceeding on **Tuesday, March 19, 2024**, via Zoom remote conferencing, beginning at **2:00 p.m.** A copy of the Instructions for Public Access to the Continued Evidentiary Hearing is attached.

The hearing shall commence with the continued appearance of the Petitioner, Windsor Solar One, LLC (WSO), for cross examination by the parties and intervenors in the order by which the requests were granted by the Council, beginning with Keith and Lisa Bress and continuing with the Grouped Resident Intervenors, followed by cross examination of the Petitioner on the **new exhibits** by the Town and the Council.

Petitioner Late-Filed Exhibits

During the February 8, 2024 evidentiary hearing session, the Council requested WSO submit the following information as late-filed exhibits:

1. Visibility assessment of the proposed facility from the west side of River Street, including locations with and without intervening trees;
2. A copy of the preliminary DEEP Natural Diversity Database determination letter received by WSO;
3. A copy of the Phase 1B Cultural Resources Survey and associated response from the State Historic Preservation Office, if available;
4. Revised Site Plan that increases the distance of the proposed facility to the north property line, and with additional landscaping; and
5. A proposed facility operational noise analysis with recommended mitigation measures, if necessary, confirming compliance with DEEP Noise Control Regulations.

The Council requests these late-filed exhibits be submitted to the Council and the service list before the close of business on **March 7, 2024**. This includes the 15 hard copies.

Please be advised that the close of business at the Council office is 4:30 PM Monday through Friday.

Direct testimony at the hearings is not permitted. This applies to all parties and intervenors.
