Please be advised that the Connecticut Siting Council (Council) made a clerical error as to the zip code in the address block for Windsor Solar One, LLC's counsel, Attorney Lee Hoffman, in the January 5, 2024 notice of public hearing and December 21, 2023 Service List for the above-referenced matter.

Connecticut General Statutes §4-177 requires a public hearing notice to be in writing and to include: (1) A statement of the time, place, and nature of the hearing; (2) a statement of the legal authority and jurisdiction under which the hearing is to be held; (3) a reference to the particular sections of the statutes and regulations involved; and (4) a short and plain statement of the matters asserted.

The statute does not specifically reference inclusion of the office address of the applicant or petitioner's counsel in the hearing notice. Therefore, a corrected public hearing notice will not be issued.
