Dear Catherine Conklin:

The Connecticut Siting Council (Council) received the petition for a declaratory ruling for the above referenced facility on December 15, 2023.

According to Section 16-50j-39a of the Regulations of Connecticut State Agencies, "no declaratory ruling shall be issued to any person until a complete petition containing all information deemed relevant by the Council has been filed."

Council staff reviewed this petition for completeness and had identified a deficiency that was more fully described in a notice of incompletion to AT&T dated December 20, 2023, a copy of which is attached for your convenience, and recommended that AT&T provide 15 hard copies; and supporting documentation on or before January 19, 2024.

On January 24, 2024, AT&T submitted a response to the incomplete request with 15 hard copies that did not include supporting documentation.

To date, the Council has not received the requested documentation. Thus, the petition for a declaratory ruling is incomplete and not in compliance with Connecticut General Statutes §16-50k, and §16-50j-39(a) of the Regulations of Connecticut State Agencies and is hereby rejected on that basis.

The Connecticut Siting Council (Council) received an email for the petition for the above-referenced facility on December 15, 2023.

According to Regulations of Connecticut State Agencies (RCSA) §16-50j-39a, "no declaratory ruling shall be issued to any person until a complete petition containing all information deemed relevant by the Council has been filed."

Staff has reviewed this petition for completeness and has identified the following deficiencies:

- 1. An original and 15 hard copies are required upon filing a petition. One hard copy was received.
- 2. Pursuant to RCSA §16-50j-39, "The request for a declaratory ruling shall be accompanied by a statement of any data, facts and arguments that support the position of the person making the inquiry." The petition does not contain supporting documentation. Specifically, the petition lacks a description of the site, area to be disturbed and any associated environmental impacts; and a depiction of the site lease area.

The Council's filing guide for a Petition for a Declaratory Ruling may be found at <u>https://portal.ct.gov/-/media/CSC/Guides/2016Guides/PetitionApplicationGuide912pdf.pdf</u>

Therefore, the petition is incomplete at this time. The Council recommends that AT&T provide 15 hard copies; and supporting documentation on or before January 19, 2024. If additional time is needed, please submit a written request for an extension of time prior to January 19, 2024.

This notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
