Nov 13, 2023	Fire Chief Scott Cunningham and Fire Marshal Capt. Eric Vincent – Suffield Fire Department	Email	Providing project outline and project fire safety details for their review and comment, requesting a meeting.

Nov 21, 2023	Bill Hawkins, Director of Planning & Development, Engineer Liaison, Town of Suffield	Email	Confirmed that Endurant would continue to request an 8 foot-high fence for safety and security reasons, however we would be guided by Suffield's preference for 'see-through' chain link, or include privacy inserts, to be advised at permitting stage.
Nov 22, 2023	Capt Eric Vincent, Fire Marshal, Suffield	Virtual Meeting	<ul style="list-style-type: none"> <li>- Covered Endurant's background and work on storage in the NE/NY, and this project specifically with Praxair.</li> <li>- Discussed that there will be need for clear signage (fire code compliant) including emergency contacts at Endurant and Praxair, updated annually and as-needed. Noted this will be included in Endurant's Emergency Response Plan, which the FD will have the chance to review and comment on before construction.</li> <li>- Talked about the alarms (physical) and also the fact that the systems are monitored 24/7, and emergency response can be triggered by the remote system. There is the possibility of also connecting directly to FD dispatch servers, but in this case Suffield FD anticipates standard alerts to the BMS and emergency response triggered by our call to you will be their preference.</li> <li>- Discussed that water be used to limit spread of fire in surrounding areas if necessary, and that Endurant focuses on fire/heat/gas detection. Industry recommendation is that in the unlikely event of a fire, it be allowed to burn out in place. Endurant would only ever use batteries that have been subject to 9540a testing, and are certified not to enable module-to-module propagation.</li> <li>- Education: Suffield FD will look to Endurant to provide walk-throughs and will consider what further training would be useful, as well as annual updates on eg best</li> </ul>
