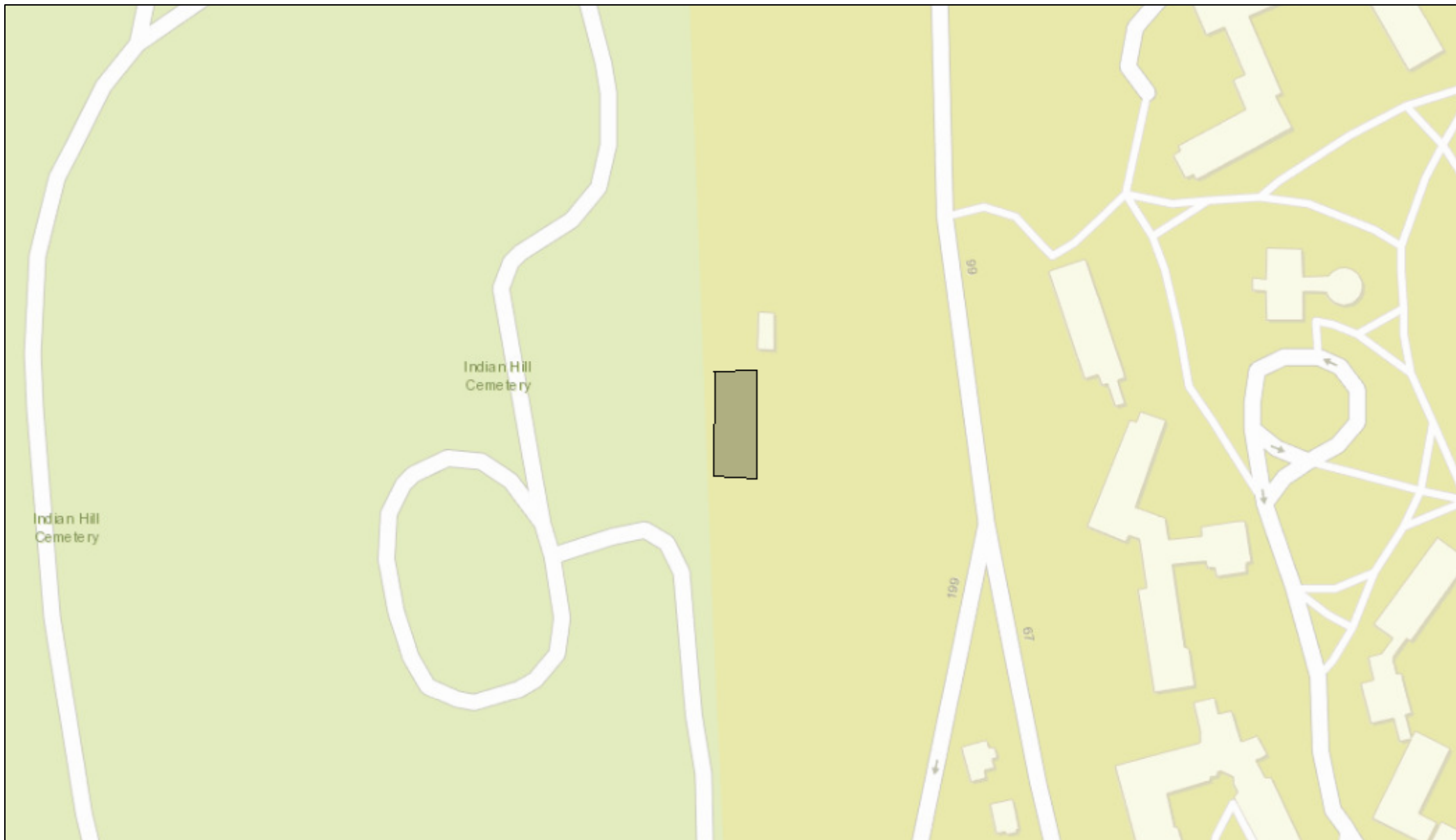

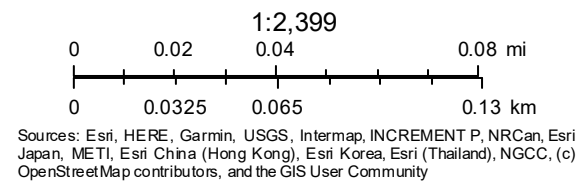

Data limitations
