The Connecticut Siting Council (Council) is in receipt of Hanwha Q Cells America Inc.'s (HQC) written consent to the extension of the deadline for the Council to render a final decision on the above-referenced petition for a declaratory ruling, dated May 13, 2024. The current deadline for a final decision is July 3, 2024.

Pursuant to Connecticut General Statutes §4-176(i), "If an agency does not issue a final decision within one hundred and eighty days after the filing of a petition therefor, **or within such longer period as may be agreed by the parties**, the agency shall be deemed to have decided not to issue such ruling." (Emphasis added).

It is the Council's understanding from the May 13, 2024 correspondence that the originally proposed facility and interconnection design require modifications according to discussions with The Connecticut Light and Power Company d/b/a Eversource Energy.

The Council acknowledges HQC's written consent to extend the deadline for the Council to render a final decision on this petition for a declaratory ruling to no later than **August 21, 2024**.
