RE: **PETITION NO. 1609** – TRITEC Americas, LLC notice of election to waive exclusion from

Connecticut Siting Council jurisdiction, pursuant to Connecticut General Statutes §16-50k(e), and petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a 0.999-megawatt AC solar photovoltaic electric generating facility located at 250 Carter Street, Manchester, Connecticut,

and associated electrical interconnection.

Continuation of Evidentiary Hearing

The Connecticut Siting Council (Council) shall continue the evidentiary hearing for the above-referenced proceeding on **Tuesday**, **May 21**, **2024**, via Zoom remote conferencing, beginning at **2:00 p.m.** A copy of the Instructions for Public Access to the Continued Evidentiary Hearing is attached.

The hearing shall commence with the continued appearance of the Petitioner, TRITEC America, LLC (TRITEC), for cross examination by the parties and intervenors in the order by which the requests were granted by the Council, beginning with the Town of Manchester and continuing with Rachel and Dana Schnabel, Manchester Advocates for Responsible Solar Development (MARSD) and Raymond Welnicki, to be followed by cross examination by the Council on the new exhibits.

The hearing shall proceed with the appearances of the parties and intervenors in the order by which the requests were granted by the Council, commencing with the appearance of the Town followed by the appearances of Rachel and Dana Schnabel, MARSD and Raymond Welnicki for cross examination by all parties and intervenors and the Council.

Petitioner Late-Filed Exhibits

During the May 2, 2024 evidentiary hearing session, the Council requested TRITEC submit the following information as late-filed exhibits:

- 1. Viewshed Profiles and Analysis from the abutting properties to the east;
- 2. Revised Noise Analysis to account for the correct location of the inverters and inclusion of the tracker system;
- 3. Spill Response and Prevention Plan that includes protocols for transformer spills and the identification of the construction vehicle refueling area;
- 4. Recalculation of the acreage of post -development core forest to include 300-foot buffers from developed areas with an associated map;
- 5. A map indicating what areas of the host parcel were historically used for agricultural purposes;

- 6. Culvert Openness Ratio for the proposed access drive wetland crossing;
- 7. Revised Site Plan Sheet with proposed access slopes at 1.5 to 1 in the vicinity of the wetland crossing, and a calculation of the associated reduced wetland impact.
- 8. An East-West profile detail of the solar array on proposed grades.

The Council requests these late-filed exhibits be submitted to the Council and the service list before the close of business on May 7, 2024. This includes the 15 hard copies.

Consistent with the Council's correspondence in response to the Petitioner's Request for an Extension of Time, dated April 24, 2024, and the Council's Revised Schedule, dated April 25, 2024, interrogatory responses and pre-filed testimony from the Petitioner and other parties and intervenors to the proceeding are also to be submitted to the Council on or before **May 7, 2024.** This includes the 15 hard copies.

Please be advised that the close of business at the Council office is 4:30 PM Monday through Friday.

Direct testimony at the hearings is not permitted. This applies to all parties and intervenors.
