


Photo 1: Carter Street looking Southwest












Photo 2: Carter Street looking South















Approximate Location of Proposed Interconnection Point





Approximate Location of Proposed Gravel Road Parking Area


Approximate Location of Proposed Detention Basin














Approximate Location of Proposed Concrete Pad
