To Ms. Bachman and the CT Siting Council:

I am writing on behalf of the Town of Manchester and its elected representatives, the Board of Directors, regarding **Petition No. 1609**, the proposal from TRITEC Americas, LLC for a 0.999-megawatt AC solar photovoltaic electric generating facility at 250 Carter Street, Manchester, CT.

As you were made aware in yesterday's letter from the Town's Planning and Zoning Commission, we've received dozens of correspondences from Manchester residents expressing reasonable concerns about the proposed facility's impact on wildlife, water management, and the surrounding neighborhood's quality of life.

Manchester is in an incredibly welcoming and innovative community that values sustainability and inclusivity. Having just constructed the state's first certified Net Zero public school, with two others set to be completed over the next year, along with several other carbon reducing projects, Manchester is a state leader in helping reduce Connecticut's carbon footprint, as evidence by our Climate Leader Designation and Silver Award status given by Sustainable CT. The Town also understands the delicate balance of the siting council in weighing the need for adequate and reliable public utility services at the lowest reasonable cost to consumers with the need to protect the environment and ecology of the state.

However, based on the quantity of comments received and the level of concern expressed by both residents and Town Planning staff, the Town of Manchester respectfully requests that the Siting Council hold its own public hearing on Petition No. 1609 before making a final decision.
