- 1. The Council established this proceeding to consider the application of Lodestar Energy's Petition for a Declaratory Ruling for the proposed construction, maintenance and operation of a 1.93-megawatt AC solar photovoltaic electric generating facility located on approximately 15.82 acres comprised of three separate parcels located generally north of Town Farm Road and east of Abbe Road in Enfield, Connecticut.
