I am writing on behalf of my client HQCA Energy Solutions, LLC (“Petitioner”) in connection with the above-captioned Petition.

On June 5, 2024, the Connecticut Siting Council (“Council”) issued Council Interrogatories to Petitioner (“Interrogatories”) requesting responses be provided by the Petitioner on or before June 26, 2024. As a result of recent discussions with The Connecticut Light & Power Company d/b/a Eversource Energy regarding the final interconnection design, Petitioner has determined that a change in the manufacturer of the battery energy storage facility (“BESF”) equipment is needed.

Petitioner is diligently working on crafting responses to the Interrogatories based on the change in BESF equipment. As a result of the change in equipment and in an effort to provide a full and complete response to the Interrogatories based on the change in equipment, additional time is required.
