1. Referencing Attachment H of the Petition, has the Town of Wethersfield and/or any abutting property owners provided comments to SNET and/or AT&T since the Petition filing? If so, please summarize the comments.

Project Development

- 2. What is the estimated cost of the proposed project?
- 3. Is the project, or any portion of the project, proposed to be undertaken by state departments, institutions or agencies, or to be funded in whole or in part by the state through any contract or grant?

Existing Facility Site

- 4. What is the square footage of the existing equipment compound?
- 5. Referencing the Council's Declaratory Rulings in Petition Nos. 1012 and 1521, AT&T shares an emergency backup generator with Frontier that is located inside the on-site equipment building. Is this arrangement no longer feasible? Explain.
- 6. How many hours of backup power does the current shared emergency backup generator arrangement with Frontier in the equipment building provide for AT&T?
- 7. Would AT&T maintain its existing lease of 280 square feet of interior building space if the proposed emergency backup generator is approved?
- 8. Would AT&T maintain its existing battery backup capability at the facility in addition to the proposed emergency backup generator?

Proposed Compound Expansion and Associated Equipment

- 9. Referencing Petition, Section IV, it states "...the proposed Generator is a fuel cell..." However, the rest of the Petition refers to the proposed generator as a diesel-fueled generator. Please clarify.
- 10. Referencing Petition site plan, sheet A-1, the drawing shows the generator outside of the fence but the Petition states it would be within an expanded fence line. If it is within the fenced area, provide a drawing.
- 11. How long would the proposed emergency backup generator run before refueling is required in the event of a power outage?
- 12. What is the capacity of the fuel tank?

13. Referencing Petition p. 2 and Attachment B – Generator Specifications – the proposed emergency backup generator would include a Level 2 Sound Attenuated Enclosure. What are the anticipated noise levels and costs associated with no enclosure, a Level 1 enclosure and a Level 2 enclosure?

Project Construction

- 14. During what work hours and days of the week would construction occur?
- 15. When would construction commence, and when would construction be completed?

Environmental Effects and Mitigation Measures

- 16. Describe visibility of the proposed expanded compound from the surrounding area.
- 17. Would any vegetative clearing be required for the proposed compound expansion? Provide the number of trees with diameters of six inches or greater at breast height that would be removed, if any.
- 18. Referencing the Council's Declaratory Rulings in Petition Nos. 1012 and 1521, would construction of the proposed compound expansion require removal and/or trimming of the 12-inch diameter cluster pine tree? Would SNET/AT&T move and replant the pine tree?
