The Connecticut Siting Council (Council) is in receipt of the request for an extension of time to respond to interrogatories for the above-referenced Development and Management (D&M) Plan dated December 3, 2025.

Pursuant to Section 16-50j-22a of the Regulations of Connecticut State Agencies, the Council hereby grants the request for an extension of time to December 17, 2025.

The Council received the D&M Plan for the above-referenced solar facility on October 16, 2025. Section 16-50j-60(d) of the Regulations of Connecticut State Agencies, entitled, "Timing of plan" states: "The D&M plan shall be submitted to the Council in one or more sections, and the Council shall approve, modify, or disapprove the plan or a section thereof within 60 days after receipt of it..."

The current deadline for the Council to approve, modify, or disapprove the D&M Plan submitted for this facility is December 15, 2025. Due to the additional time to respond to interrogatories and the next regular energy and telecommunications meeting scheduled for January 8, 2026, the Council will need additional time to review the D&M Plan. The Council hereby requests an extension of the D&M Plan decision deadline for Petition 1655 until January 9, 2026. Please respond in writing by December 10, 2025.
